Take Care of What We Have

Facilities

- o Preventative Maintenance with Direct Fitness Solutions is scheduled for September 26-27.
- Staff painted the shower areas and reinstalled the shower partitions, benches, coat hooks, and soap dispensers in the downstairs locker rooms at FVRC.
- o SRC shutdown: cleaned, painted, and Room 3 floor refinished.
- Staff removed two trees obscuring the north entrance at SRC.
- Last parking lot light that was affected by a surge in June was repaired. A lift was needed to access & repair. The lift was also used to remove the shade sail at CCWP.
- New flooring was installed in the gymnastics room on the spring floor. The foam/carpet combination matches the purple floor in SRC room 6 and is thick, supportive foam with easier cleaning and the ability to roll up to be moved.





Parks

- Staff prepared Community Park for the grand opening on September 9. Staff mulched, power washed and distributed freshly painted trash cans.
- Staff removed metal posts installed over a decade ago from the water's edge at Evergreen Lakes boat launches.
- o Staff adjusted the gate to the pickle ball courts at Walter Park so balls can't roll under it.
- Staff spread dirt and reseeded along the ramp leading to Evergreen School that was installed last year. Some of the dirt had washed away from rain.
- o Staff continue working on repairing and touching up paint on various park signs.

- Forte Dance Company held a parent meeting on September 5 to welcome new families and discuss the upcoming competition season.
- Preschool "Meet the Teacher" took place on August 22. Students were able to visit their classrooms, drop off their school supplies and meet their new classmates and teachers.







- Staff is exploring options to retrofit Simkus Recreation Center with a keyless swipe card entry. This will address issues with retrieval of keys when employee leave the District, as well as the projected need to replace all lock cores in the few years.
- Registration Manager prepared a grant proposal to PDRMA to help offset the cost of removable speed bumps for the SRC parking lot. Cars cut through the lot all the time and many drive very fast. We are hoping these speed bumps will force drivers to slow down and make the parking lot safer for patrons walking in and out of the building.

- Free Fitness Week from August 19-25 had 149 participants.
- 90 New members took advantage of the \$0 enrollment special.
- Participation numbers in popular fitness classes continues to average over nine participants per class.
- August Fitness Fun Class "Summer Send Off Celebration" was a success, bringing in 20+ participants.



- The 500 Mile Challenge began in January 1 and 138 members are currently participating. Six members have completed 500 miles.
- The August Member Challenge asked members to burn 4000 calories during August; 36 members participated and the winner received a \$50 Dick's Sporting Goods gift card.
- Dolphin's Swim team has started September 9, and has 137 swimmers for the upcoming fall/winter season. Last year we had 159 participants.
- Adult Cup in Hand Kickball started this past Monday, and had 10 teams this upcoming season. We had 12 teams last year.
- Coyote Crossing Mini Golf started the Fall Adult Mini Golf League on September 4 with 21 teams.





• A second Route 66 adult trip was added in August to accommodate the waitlist. 26 were enrolled, with \$1,820 in unbudgeted revenue.



- 30 participants attended the Springers Gymnastics Team tryouts on August 13.
- Springers Gymnastics Team is kicking off their season with a new mid-level, Shining Stars. In addition to the 50 team members, there are two on Tumbling Team who will practice and compete through March.



- 43 participants auditioned for the Forte Dance Company on August 19.
- Storm Poms will have two competitive teams this year: Minis (ages 5-8) with 11 registrants and Youth (ages 9-11) with seven registrants. New uniforms are coming soon.



 Awesome Adventure Camp concluded on August 20 and served 332 individual registrants over the summer. Weekly averages were: Summer Camp – 156, Before Camp – 43, After Camp – 22. Highlights over the last week included a balloon animal show and Funway field trip.







- The Summer Camp survey came had 60 responses and an average rating of 3.94 out of 5. The Outdoor Adventure Camp Survey had 18 responses and an average rating of 4.34 out of 5. Camp survey results will be used to make improvements for next summer. Testimonials:

- The 2023-2024 Activkids Before & After Care survey had 16 responses and an average rating of 4.53 out of 5.

- Activkids Before & After Care has 709 school year registrations compared to 802 this time last year. 54 daily flex passes have been sold this school year to date compared to 69 last year. The program is serving 146 individual registrants.









• Preschool classes started on September 3-4. Preschoolers are slowly adjusting to being away from their parents. Quote from the first day, "I love this preschool!"

 recommendations as to what to do and what NOT to do when interacting with these individuals.
