**Discussion:** Bike Security at Coral Cove Water Park

Follow up **Agenda Item #:** 6A

#### Commissioners,

Staff would like to provide the Board an update on our findings in regards to Bike Security at Coral Cove Water Park (CCWP).

## Since the August 12, 2024 Board Meeting the following actions or discussions have taken place:

- 1. The Marketing Team created an educational video reminding bike riders to lock their bikes when visiting CCWP.
- Staff reviewed internal incidents and incident reports for the last two years. We found
  one incident from 2023 that referenced a stolen bike. This unlocked bike, however,
  was taken by another child to use as a way to climb over the fence to sneak in to the
  CCWP. It was left on our property, recovered by JEM and returned to the owner of the
  bike.
- 3. Staff inquired to JEM if they were able to search their incident forms for reports of stolen bikes. They do not have a search feature so we were unable to collect data from JEM.
- 4. Staff has contacted the Carol Stream Police Department and submitted a FOIA request for the number of reported stolen bikes from CCWP in the last two years. As of the time of this memo's writing, we had not received the FOIA response.
- 5. We have consulted with PDRMA in regard to liability; they have no issues with a camera being installed.
- The direct cost to purchase/integrate an additional outdoor camera is \$460.
- 7. <u>The indirect costs could be unstainable</u>. Our video surveillance system does not have a search/sort feature so any retrieval of footage would require staff time to watch hours of video in order to find the segment of a bike theft to provide the police.
- 8. Footage can show us a bike being stolen, but unless police are familiar with the offender, there is no way to track them down. We can't share the video with parents/children whose bikes have been stolen; it can only be shared with the police.

9. A bike lock check-out program can in implemented, but it only works if the bike owner takes the initiative to stop at the cashier's station and check out a lock. Staff believe it's that same lack of initiative that causes kids not to lock their bikes now.

Our goal is for guests to have a great experience at CCWP; we understand that having your bike stolen ruins that. In all instances that we are aware of, stolen bikes were not locked. Police have told us that bike thefts happen because children continue to leave their bikes unlocked.

#### Recommendation

It is staff's recommendation to continue to share our bike safety campaign to the public; specifically promoting it as the beginning of the pool season, and regularly throughout the year.

We also plan to work with the Police Department next pool season to help us promote the importance of locking your bike, and registering bikes through the police department.

#### Issue

That the Board approve a 4% merit pool for the 2025 budget year.

#### **Background/Reasoning**

This item was discussed at the September 9, 2024 Board Meeting at which time direction was given to move this item to approval. Per the Salary Administration Policy & Procedure, the Board of Commissioners must annually approve the District's merit pool. In accordance with our policy, the District's formal wage scale will increase by 1% less than the annual merit pool.

Supporting documentation explains the importance of retaining high quality staff as a way to ensure our District remains competitive in attracting and retaining excellent employees, while also recognizing and rewarding the efforts of our dedicated employees.

A 4% merit pool will address these challenges and renew the District's initiative to remain the employer of choice in the parks and recreation field.

**Discussion:** 2025 Merit Pool Recommendation

Agenda Item #6A

At the September 23, 2024 Board Meeting, we will be seeking approval for a 4% Merit Pool for the 2025 Budget. Below you will find information supporting this recommendation for the Board's consideration. Per the Salary Administration Policy & Procedure, the Board of Commissioners must annually approve the District's merit pool.

The state's mininimum wage will see another \$1 increase (7.14%) in January to \$15 per hour; this represents an aggregate increase of 81.8% from the \$8.25/hour minimum in 2018. Of the Districts 294 active employees, 255 are part-time, and 246 will see an increase due to the new minimum wage. As we have had to adjust minimum wage annually since 2018, we have had some unintentional compression to our full-time wage scale. That factor is considered in this recommendation.

#### Rationale for a 4% Merit Pool:

- 1. **Performance-Based Compensation:** The merit pool does not equate to an automatic salary increase. Instead, it is designed to reward employees who have demonstrated exceptional performance and contributed significantly to the organization's success. A 4% meirt pool would allow us to reward high-performing staff members appropriately and acknowledges their hard work, dedication, and achievements.
- 2. **Staff Retention and Recruitment:** In today's competitive job market, a 4% merit increase will help us stay competitive with agencies in our area and the recreation industry. Recruiting and retaining top talent is essential for the continued success of our District. Offering competitive wages is one of the key factors to attract and retain employees as well as reduce the costs and disruptions associated with high turnover rates.
- Organizational Impact: Employees who feel valued and fairly compensated are more likely to be engaged and productive. Investing in our workforce through merit increases can lead to high morale, strong performance outcomes and overall success to the District.
- 4. **Financial Considerations:** We have reviewed our budget and financial forecasts to ensure that a 4% merit increase is feasible and sustainable. This adjustment will be implemented in a way that balance financial responsibility with our commitment to employee satisfaction.

#### Market Competitiveness:

- The Society for Human Resource Management (SHRM) projects the national average for merit increases in 2025 as 3.5%.
- The table shows merit pool percentages from other park districts in our WDSRA group, along
  with several other neighboring agencies. Districts reporting TBD have a May-April Fiscal Year
  therefore their merit pool information is not yet available. We will update the table for the next
  board meeting with any new information that becomes available.

#### Issue

Shall the Board approve the addition of Section 31 to the Carol Stream Park District Park Rules and Regulations Ordinance No. 411 to prohibit the use of Electric Scooters at all District parks and properties.

#### Background/Reasoning

On August 9, 2024, Illinois Passed <u>Public Act 103-0899/SB</u> 1960, a new law regarding operation and regulation of low-speed Electric Scooters at park districts, forest preserves, municipalities and conservation districts.

We have sought guidance from PDRMA, IAPD, and Corporate Counsel in regards to prohibiting the use of Electric Scooters on district property. Staff worked directly with Corporate Counsel on the creation of this new rule and feel that this will be a crucial tool in keeping park guests safe as well as defending tort claims.

#### Cost

#### **Public/Customer Impact**

Electric Scooters can pose risks to pedestrians, especially in parks where people of all ages and abilities are present. Further, they can cause damage to park grounds, trails and landscapes.

#### Recommendation

That the Board approve the addition of Section 31 to Carol Stream Park District Park Rules and Regulations Ordinance No. 411 to prohibit the use of Electric Scooters at all District parks and properties.

#### SECTION 31 – MOTORIZED VEHICLES AND OTHER DEVICES

#### Section 31.a Use of power-driven mobility devices other than wheelchairs

No Person shall drive, ride, or otherwise operate a "low speed electric scooter" as defined by the Illinois Vehicle Code, 625 ILCS 5/1-140.11, within the Park System. No Person shall drive, ride, or otherwise operate an all-terrain vehicle, go cart or any power-driven mobility device, including but not limited to electric powered bicycles, mopeds or Segways, on District Property, except as authorized by Section 32.02 or by the District's Other Power-Driven Mobility Devices Used for ADA Purposes Policy. The regulations set forth herein shall not apply where necessary to make a reasonable accommodation for use of the Park System under the Americans With Disabilities Act. For purposes of this section, an all-terrain vehicle shall be defined as any motorized off-highway device 50 inches or less in width, having a manufacturer's dry weight of 600 pounds or less, traveling on three or more low-pressure tires, designed with a seat or saddle for operator use, and handlebars or steering wheel for steering control.

#### Section 31.b Use of Micromobility Devices

Micromobility Devices refer to a category of small, lightweight devices designed for personal transportation. Micromobility Devices do not include "low speed electric scooters" as defined by the Illinois Vehicle Code, 625 ILCS 5/11-140.11, which are prohibited at all times within the Park System, these devices are typically designed for use in urban and suburban areas to facilitate short-distance travel. Common examples include:

- (a) Electric bicycles (e-bikes): Bicycles equipped with an electric motor that assists with pedaling (i.e., Class 1 e-bikes), making it easier to travel longer distances or up hills without excessive exertion. Bicycles powered by an electric motor controlled by a hand throttle rather than by pedaling (i.e., Class 2 and Class 3 e-bikes) are not permitted on District Property.
- (b) Hoverboards: Self-balancing boards with two wheels, powered by batteries.
- (c) Skateboards: Electric-powered skateboards used for short trips.
- (d) Segways: Two-wheeled, self-balancing personal transporters.

No Person using Micromobility Devices shall interfere with pedestrian use of sidewalks or vehicle use of the streets, or otherwise act negligently, recklessly or without due caution, or in any manner so as to endanger any Person or property nor use same where such use has been posted as prohibited.

When two or more Persons in a group are operating Micromobility Devices, they shall not ride abreast, but shall ride in single file.

No Person operating a Micromobility Device shall cling or attach any part of themselves or their Micromobility Device to any other moving vehicle.

The operator of a Micromobility Device emerging from an alley, driveway or building shall, upon approaching a sidewalk or the sidewalk area extending across any alleyway, yield the right-of-way to all pedestrians approaching on said sidewalk or sidewalk area, and upon entering the roadway shall yield the right-of-way to all vehicles approaching on said roadway.

No Person operating a micromobility device shall carry another Person on the same device. This restriction does not apply to tandem bicycles or child safety seats. In those cases, there shall be only the number of Persons on the bicycle as there are seats or saddle.

No Person shall operate an electric bicycle on District property between thirty minutes after sunset and thirty minutes before sunrise, without a clear, white, properly lighted headlight, visible under normal atmospheric conditions from the front therefore not nor less than 500 feet and firmly attached to the device, and without a red reflector firmly attached to the device, which is clearly visible in the headlight beam of an automobile for a distance of 500 feet to the rear of the bicycle.

No Person may operate a Micromobility Device on District playground surfaces, athletic fields, athletic courts, or sidewalks except small children riding three or more-wheeled bicycles while under the supervision and control of an adult. This restriction does not apply to operating a bicycle on a designated bicycle pathway.

No Person shall ride a Micromobility Device on any park district owned or managed street or path where signs are posted prohibiting riding Micromobility Devices on those streets or paths.

Micromobility Devices shall not, at any time, in any place, be indiscriminately parked by anyone in such a manner as to actually or possibly interfere with pedestrians or traffic, or with Persons getting into or out of automobiles. No Person shall leave a Micromobility Device lying on the ground or pavement or set against trees or otherwise in a place that may create a safety hazard or interfere with the use of the area for recreational purposes. No Person shall move or in any manner interfere with, any Micromobility Device which is properly parked, nor shall any Person interfere with, or in any manner, hinder any Person from properly parking a Micromobility Device.

All Micromobility Devices, when operated on roadways, shall be kept to the right and shall be operated as nearly as practicable at the right-hand edge of the roadway or path.

No Person shall operate a Micromobility Device faster than is reasonable and proper, and every Micromobility Device shall be operated with reasonable regard for the safety of the rider and of other Persons and property.

Every Person operating a Micromobility Device within the District shall observe all federal, state, local and District traffic rules and regulations applicable to motor vehicles, except those provisions of this chapter which by their nature can have no application to the operation of a Micromobility Device and except as otherwise provided by this section.

Electric cycles are only allowed on District trails if they are Class 1 electric cycles. By federal standards, an electric cycle is considered a "cycle" (not a motorized vehicle) as long as it meets the following criteria:

It must be low speed (an electric motor of less than 750 watts).

- (a) It must have a maximum speed of less than 20 miles per hour.
- (b) It must have functional pedals.
- (c) The rider must be at least 16 years of age.

Motorized cycles or other similar devices propelled by gasoline, propane, or any other combustible fuel, are prohibited from District trails and park district owned roadways.

#### Issue

Should the Board approve an agreement for a term of 12 months with Constellation for our electric services at a rate of 0.064220 kWh.

#### **Background/Reasoning**

- Our current contract with Constellation is due to expire in October 2024.
- Our current rate is \$0.053510.
- New rates range from \$0.062700 to \$0.071760 ranging from a 17% increase to a 34% increase.
- Electric is a commodity and pricing is volatile.
- This includes services at Fountain View Recreation Center, Simkus Recreation Center, Parks Maintenance, Coyote Crossing Mini Golf and McCaslin Park.

#### Cost

The Carol Stream Park District wishes to pay the lowest kWh rate available. However, at this time all current rates are above our existing rate we currently hold with Constellation.

#### **Public/Customer Impact**

This will give our utility broker and staff time to watch the market closely in an attempt to secure a better rate for the future of the District.





#### Issue

Should the Board approve the index option and authorizes the Executive Director to lock in a rate for the natural gas contract in the future when our energy broker believes conditions to be favorable for the District.

#### **Background/Reasoning**

- Our current contract with Constellation is due to expire in November 2024.
- Our current rate is \$0.459112.
- New fixed term rates range from \$0.408200 to \$0.448700 resulting in a 2% decrease to an 11% decrease.
- There is an additional option called "the index." In August 2024 the index rate was \$0.2340 + \$0.08 totaling \$0.314. Currently this is the cheapest option. The negative to this option is the rate can fluctuate month to month. However, there is an option to lock in a rate when we believe it to be favorable for the District. (Our energy broker will be on site to discuss this option in depth.)
- This includes services at Fountain View Recreation Center, Simkus Recreation Center, Parks Maintenance, Coral Cove Water Park and Coyote Crossing Mini Golf.

#### Cost

The Carol Stream Park District wishes to pay the lowest therm rate available for natural gas. We can select a fixed rate which is lower than our current contract. We will also present the option of 'the index.'

#### **Public/Customer Impact**

Utilities are a commodity meaning they are, by nature, volatile. Prices for natural gas are a bit more favorable at this time. The decision will be how much savings does the Board wish to secure.
